To the new applicants of a FIM Press Card

Re: Issue of the FIM Press Card

Dear Sirs,

Please find attached the application form for the **FIM Press Card**. Please note: this form concerns only the **new applicants**. Current holders of a FIM press card can directly apply for renewal in the website with their login and password.

In order to take your request into consideration, we should like to draw your attention to the following points:

- It is imperative that *every question* appearing on this form be duly completed.
- It is of utmost importance that *all requested documents* be attached.
- It is imperative that your application *be approved by the National Motorcycling Federation* which must stamp and sign the application.

Furthermore, please note the following points :

- The FIM Press Card is issued only for the discipline(s) covered by the holders and is valid only at the corresponding events.
- There will be *no exchange of correspondence* with regard to the issuing of the FIM Press Card.
- Refusals will be neither justified nor notified in writing.
- The renewal of the FIM Press Card is made electronically through the FIM website.
- The validity of the FIM Press Card is of two years as from the date of issue.
- The FIM Press Card does *not* carry with it the right to film without the authorisation of the Promoter and/or Organiser.
- The FIM Press Card is *not* a Press Pass. It is merely a document which entitles its holder to receive a non-permanent, one-event media FIM Pass directly from the Organiser of an event.
- Accreditation requests at an event shall apply only when the holder of a FIM Press Card has registered in writing at least one week in advance.
- The holder of the FIM Press Card agrees to abide by the rules, conditions and limitations imposed by the Organisers to ensure the proper and safe running of the event.
- *The FIM Press Card is issued to the holder at his own risk and he assumes full responsibility for it. This card is not transferable and improper use will result in its immediate withdrawal and cancellation.*

We thank you in advance for your understanding. Our aim is to issue the FIM Press Card only to professionals working in the field of the motorcycling sport and to avoid any possible abuse.
